

**The Outcomes of the visit of H.E. Kittinitikosabindit Senior Minister OM YENTIENG, President of Anti-Corruption Unit to Indonesia's Corruption Eradication Commission (KPK Indonesia)**

The visit of H.E. Kittinitikosabindit Senior Minister OM YENTIENG, President of Anti-Corruption Unit (ACU) from 8<sup>th</sup> to 9<sup>th</sup> March 2023 to Indonesia's Corruption Eradication Commission (KPK Indonesia) has the following important outcomes.

Following the bilateral meeting both sides highly valued the significance of the visit particularly through the mutual enhancement and exchange of cooperation between KPK Indonesia and ACU Cambodia as friends in ASEAN and also as parties of the ASEAN Parties Against Corruption (ASEAN-PAC) which is considered by the anti-corruptions in ASEAN to be more than neighbors as brother and sister institutions to help each other in spirit in all circumstances. The Indonesian side provided a warm hospitality to the ACU delegation and recalled that both countries have a long history and Cambodia is similar to Indonesia since the Java Dynasty and the Khmer Empire were like brothers and sisters for a long time in history. This visit is more than cooperation in the sense that it is one of the most important opportunities to learn, exchange experiences and help each other as brothers and sisters, and as parties of the ASEAN-PAC towards the future of anti-corruption work as well as aiming to improve the corruption index in both countries.

2. **H.E. Mr. FIRLI BAHURI** expressed his pleasure to strengthen a closer bilateral cooperation by helping to enhance the capacity of the ACU Cambodia especially on education and prevention. In the spirit of friendship and brotherhood, **H.E. Kittinitikosabindit Senior Minister OM YENTIENG** welcomed **H.E. Mr. FIRLI BAHURI** and KPK delegation to visit Cambodia at an appropriate time.

- 3.6. Coordination Meeting between KPK Indonesia and ACU Cambodia and trilateral meeting between KPK Indonesia and ACU Cambodia via online with the United Nations Office on Drugs and Crime (UNODC) on Preparations for the ASEAN-PAC Workshop in May 2023 in Jakarta, Indonesia.
